- $2. \ (2)$  RSUs convert into common stock on a one-for-one basis at the time of vesting.
- 3. (3) Reflects an aggregate of 293 shares of common stock retained by Heidrick & Struggles International, Inc. (the "Issuer") to satisfy tax withholding obligations with respect to 2017 RSUs that vested on March 9, 2020.
- 4. (4) Reflects the vesting of the second of three installments of RSUs granted on March 9, 2018 ("2018 RSUs"). RSUs are service-based and vest in three equal installments on the first, second and third anniversaries of the date of grant
- 5. (5) Reflects an aggregate of 381 shares of common stock retained by the Issuer to satisfy tax withholding obligations with respect to 2018 RSUs that vested on March 9, 2020.
- 6. (6) Reflects the vesting of the first of three installments of RSUs granted on March 8, 2019 ("2019 RSUs"). RSUs are service-based and vest in three equal installments on the first, second and third anniversaries of the date of grant
- 7. (7) Reflects an aggregate of 256 shares of common stock retained by the Issuer to satisfy tax withholding obligations with respect to 2019 RSUs that vested on March 8, 2020.
- 8. (8) On March 9, 2017, the reporting person was granted 3,086 RSUs, which are service-based and vest in three equal installments on the first, second and third anniversaries of the date of grant.
- 9. (9) On March 9, 2018, the reporting person was granted 3,941 RSUs, which are service-based and vest in three equal installments on the first, second and third anniversaries of the date of grant.
- 10. (10) On March 8, 2019, the reporting person was granted 2,698 RSUs, which are service-based and vest in three equal installments on the first, second and third anniversaries of the date of grant.
- 11. (11) Each RSU represents a contingent right to receive one share of Issuer common stock.
- 12. (12) RSUs are service-based and vest in three equal installments on the first, second and third anniversaries of the date of grant.
